- TC will get the mold sprayed in the pool bathrooms and ready for new paint.
- A new Texas flag will be replaced due to wear and tear. Maria said she will get one ordered for us. Old flags will be given to a boy scout troop for proper disposal.

- The board agreed on May 1st for our Community Garage Sale. Cheryl will be notifying the community for any HO's that want to participate. Mike Waskowitz will help with getting signs out for all participating homes.
- Need pest control for ants in the tennis court and pool deck area. Cheryl to contact Noack.
- Large pine tree on community property is dying/dead and needs to be removed. Getting bids for removal.
- Maria requested that we change out lights inside the clubhouse bathrooms to have motion sensors switches. Cheryl will contact electrician to change out fluorescent lights to LED fixtures.
